IDENTIFICATION OF THE REQUESTED AUDIOVISUAL DOCUMENT:

Hereafter referred to as « **DOCUMENT** »

In exchange for the granted license, the **LICENCEE** will pay **L'OEIL FOU** two hundred dollars (200.00 \$) (plus tax, if applicable).

All the terms and conditions listed on page 2 form an integral part of the present agreement.

TERMS AND CONDITIONS

1. **L'OEIL FOU** grants the **LICENCEE** non exclusive authorisation to use the **DOCUMENT** for the purpose of non commercial screenings, in an academic context and/or for political or community group activities. The use must be in a closed circuit. All other use of the **DOCUMENT** by the **LICENCEE** is strictly forbidden.
2. The rights granted by **L'OEIL FOU** to the **LICENCEE** are for an **unlimited period**.
3. The **LICENCEE** cannot reproduce the **DOCUMENT** in any matter or allow it to be reproduced in part or in its entirety without the prior written consent of **L'OEIL FOU**.
4. **L'OEIL FOU** reserves the right, with prior written warning, if the circumstances are justified, to withdraw the **DOCUMENT** if its use is reasonably susceptible to infringe upon the rights of a third party, to break a law and/or a judgement from a court or from a duly authorised government organization.
5. The **LICENCEE** cannot present or use the **DOCUMENT** as evidence in a court of law, tribunal, and/or judiciary or extra-judiciary committee without prior written warning to **L'OEIL FOU** to inform of the intent to do so.

6. If the **LICENCEE** fails to conform to each and every term and condition of the present agreement, **L'OEIL FOU** can, at its sole discretion, revoke unilaterally and immediately the present license, all without prejudice and recourse to compensation and indemnity in all cases.
7. The **LICENCEE** indemnifies **L'OEIL FOU** and holds it free from any damages, loss or expenses, legal fees or expenses, which can cause a claim or a lawsuit which could result from a use of the **DOCUMENT** other than that described in article 1 or resulting from the improper execution or the non-execution of its obligations in the present contract or of the guarantees stipulated.
8. This agreement will be governed by and interpreted in accordance with the applicable statutes of the Province of Québec.
